The Board is pleased to announce that Huadong Feitian entered into the Main Construction Contract on 21 April 2011 with China Construction Second Engineering Bureau for the construction of A8 Building (also known as the Digital Music Hub of Southern China) for an aggregate Consideration of RMB 91,377,071.90 (equivalent to approximately HK\$ 107,502,437.53).

As the applicable percentage ratio as set out in the Listing Rules is more than 5% but less than 25%, the transaction contemplated under the Main Construction Contract constitutes a discloseable transaction of the Company under Chapter 14 of the Listing Rules. Accordingly this announcement is issued by the Company to the Shareholders as required under the Listing Rules.

The Consideration of RMB 91,377,071.90 (equivalent to approximately HK\$107,502,437.53) to be paid by the Group for the Main Construction Works includes costs for the construction works as set out in the drawings, foundation works, construction and installation works for the basement parts, construction and installation works for the overground parts, chilled water storage works, decoration works for public areas, construction and installation works for outdoor areas, installation works of prefabricated parts for the curtain wall, equipments (chillers, generators, high and low voltage power distribution cabinets, floor air conditioning units, etc.) installation and coordination cost, and management and coordination cost of designated sub-contracting projects such as curtain wall, fine decoration and elevators.

The estimated total construction cost for A8 Building is tentatively fixed at RMB218,456,631 (equivalent to approximately HK\$257,007,801), among which, RMB91,377,071.90 (equivalent to approximately HK\$107,502,437.53) is to be paid to China Construction Second Engineering Bureau for the Main Construction Works. The Directors consider that since the construction project is awarded to the winning bidder by way of open tender, the consideration to be paid for the construction project is fair. The Directors are of the view that the terms of the Main Construction Contract are fair and reasonable and in the interests of the Company and its Shareholders as a whole. The Consideration will be funded by internal cash resources of the Group or bank loans if deemed necessary by the Company.

INFORMATION OF THE GROUP, HUADONG FEITIAN AND CHINA CONSTRUCTION SECOND ENGINEERING BUREAU

The Group principally engages in the business of digital music. It sources its music contents from its own highly successful interactive UGC platform, www.a8.com, as well as from international and domestic record labels, and sells the music contents to mobile phone users in the PRC.

Huadong Feitian, a limited liability company established in the PRC which is indirectly controlled by the Company through structure contracts, is principally engaged in the business of, among others, research and development of computer hardware and software and information networking systems, advertising businesses and value-added services for telecommunications.

China Construction Second Engineering Bureau is a wholly-owned subsidiary of the China State Construction Engineering Corporation (中國建築股份有限公司) (China State Construction Engineering Corporation is a listed company managed by the State-owned Assets Supervision and Administration Commission of the State Council (國務院國有資產監督管理委員會) and was ranked no.187 by Fortune 500 in 2010 and ranked no.14 by Top 500 Chinese Enterprises in 2010).
